# Information sheet for B.Tech. / B.Arch. Admission 2023-24 through JoSAA/CSAB – 2023

Venue: Main Building, Second Floor, Room No. D4

The candidates who had provisionally **allotted a seat** in B.Tech./B.Arch. programs of National Institute of Technology Raipur for the academic year 2023-2023 through the following counselling processes:

- I. The candidates who got allotted and accepted seat (First to sixth rounds) in JoSAA-2023 and paid the Partial Admission Fee (PAF) online from their JoSAA portal (29<sup>th</sup> July 1<sup>st</sup> August 2023)
- II. The candidates who have participated in **CSAB-2023** (First and second rounds) and allotted the seat and paid all the required fee as mentioned in CSAB/JoSAA 2023 procedure.

The admission procedure for the above eligible candidates who have done all the required formalities as per the Instructions / Business Rule of JoSAA- 2023 and Instructions / Information Brochure of CSAB – 2023 Special Round are as follows:

#### **Procedure for Reporting in Person at NIT Raipur**

1. The candidates who have done all mentioned formalities as per Instructions of JoSAA/CSAB-2023 are hereby informed to access the institute MIS/login through ONLINE mode before physically reporting as per the scheduled mentioned in <u>Table-1</u> to NIT Raipur for admission. The link for the same is given below (the link has also been sent to your registered email id as per JoSAA/CSAB records), which will be activated onward **08 AM**, **14**<sup>th</sup> **August 2023** (subject to the allotment of CSAB Special round 2):

The candidates need to login in the institute interface (MIS) for provisional admission through their JEE(Main) Application Number, Date of Birth, and other credentials. Please fill all the editable fields as provided at your login, with your correct information and upload your photo and signature. An email will be sent to your registered email id on successful completion of above entry on the MIS. You need to show this email at the counter (Help Desk and Registration

Counter) at the time of Physical reporting to the institute. In case of any difficulty in MIS related issues, the candidate can write email to <a href="mailto:ugadmission2@nitrr.ac.in">ugadmission2@nitrr.ac.in</a>.

Kindly note that without the completion of formalities of JoSAA/CSAB - 2023, this step and login will not confirm your admission at NIT Raipur. During verification by officials if it is observed that you have not done the formalities as per the instructions, your entered data will be removed from the institute database, and you will be treated as unadmitted/cancelled candidate.

- 3. **Fee Structure:** Please refer # No. NITRR /R-1/2022-23/102, Dt. 25/05/2023.

**Please note** that the given fee structure is semester-wise fee. The receivable amount of the allotted candidates from JoSAA/CSAB-2023 is greater than the first semester fee, hence the candidates are not required to pay the **institute academic fee** for this semester during admission ( $14^{th} - 21^{st}$  August 2023). The students need to pay the second semester fee (as applicable) during registration of II Semester (Spring - 2024).

ii. **Tuition Fee Remission:** GEN/GEN-EWS/OBC-NCL candidate claiming/ availing the remission of tuition fee must have to produce the family income certificate issued from competent authority (e.g. DM /DC /SDM /SDO /Tahsildar) for the latest financial year. Income certificate must be issued on or after 01/04/2023.

Without valid income certificate, student will not be given remission of tuition fee.

- 4. **Documents Required:** The eligibility and other criteria will be as per the JoSAA/CSAB-2023 Business rule. The following **essential documents** mentioned below are required to be produced in **original** at the time of Physical reporting / admission (**Please bring self-attested one set of photocopies of all documents listed below and arrange the same in order as follows.):** 
  - i. Duly filled admission form (Given in Annexure I, page: 07 of this Bulletin) along with 2 color passport size photographs.
  - ii. Document Verification cum Seat Acceptance Letter received online from JoSAA/CSAB portal.
  - iii. Printout of current seat allotment.
  - iv. Score Card of JEE(MAIN) 2023.
  - v. Class X (High School) Mark sheet / Board Certificate as proof of name & date of birth.
  - vi. Pass Certificate and Marks sheet of qualifying examination (class XII).
  - vii. Certificate of **OBC-NCL/GEN-EWS/SC/ST** category (as applicable), issued by the competent authority in the prescribed format (can be downloaded from <a href="http://josaa.nic.in">http://josaa.nic.in</a>)

The OBC-NCL / GEN-EWS certificate must be issued on or after April 1, 2023.

The OBC-NCL certificate should clearly mention that the candidate belongs to non-creamy layer.



- ix. **Medical Certificate** (in specified Format available on JoSAA /CSAB–2023 format)
- x. Transfer certificate/ School leaving certificate/college leaving certificate as applicable.
- xi. **Migration certificate** (from board/university, as applicable).
- xii. **Character / Conduct certificate** (if the conduct is mentioned in TC, then not required).
- xiii. Aadhar Card (compulsorily) and / or any Govt. issued identity proof card.
- xiv. Income certificate (<u>if applicable</u>) issued from competent authority (e.g.DM/DC/SDM/SDO/Tahsildar) for the GEN / OBC-NCL / GEN-EWS candidate claiming for the remission of tuition fees for the latest financial year. <u>Income</u> certificate must be issued on or after 01/04/2023.
- xv. Soft copy of formal color (white background) passport size **photograph** (50 to 100 kb) & soft copy of **signature** in size (20 to 50 kb). [If already uploaded in institute MIS login, then not required]
- xvi. **Cancelled Cheque** / First Page of Bank **passbook** (bank account should be in the name of Students /Parents) [This is required for the refund of excess fees, if any].
- xvii. Affidavit/undertaking (Annexure-IIA/IIB and III given at Page 8-10 of this Bulletin, Annexure IIA and III must be Notarized by Oath Commissioner)
- xviii. **Other Documents (if applicable)** such as additional affidavit /undertaking, Passport, Proof of place of examination Center for Open School candidates, etc.

#### *Note:*

- 1. Original documents mentioned under points (ix), (x), (xi), (xi) and (xvii) will be retained by the institute and remaining documents will be returned to the candidate after verification.
- 2. One set of self-attested copies of all the documents listed above.
- 3. If the original certificates are not in Hindi/English, duly certified Hindi/English version/translation of such certificates will be required.
- 4. Candidates are instructed to keep sufficient number of Photostat copies of the original documents submitted.
- 5. **Flow of the process** during physical reporting as per the respective dates mentioned in Table 1:



#### 6. Hostel Accommodation:

- a. **Only limited number of seats for boys & girls are available** in the hostels of the Institute which are allotted strictly based on merit and category.
- b. The candidates are advised to make alternative arrangement, in case, they are not able to get the hostel accommodation.
- c. After institute admission, interested students must have to contact hostel admission counter at the institute. Details of hostel admission fee are given at in the institute website (<a href="http://www.nitrr.ac.in/hostel.php">http://www.nitrr.ac.in/hostel.php</a>). Hostel fee must be deposited only after hostel seat is allotted to a student.
