- Criteria for allotment: Merit, category and distance of hometown from Raipur.



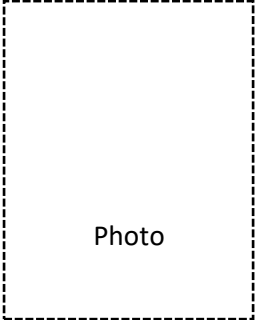
