- 2. Failing to report to the Institute within the stipulated time (period) may cause cancellation of the allotted seat in the M. Tech. programme of the Institute.

#### Procedure of applying for admission and document verification: -

- A notice containing the venue of reporting to each department will be prominently displayed at the entry gate. The candidates will be guided by the security staff present at the gate.
- The candidates are required to go to their respective venue only. Upon their arrival at the respective venue, the candidates must get their documents verified and submit a complete set of photocopies of the abovementioned documents along with the duly filled admission form. Documents listed under serial no. 12, 13, 14 and 16 must be submitted in original.
- The candidates will receive their MIS login details at the time of reporting wherein they have to enter their details. The candidates are required to bring a combined PDF file of the above documents, whichever is applicable (as listed above under point 1-16) for uploading in the MIS at the time of registration.

Candidates must complete this MIS activity when directed at the time of document verification. In case of not doing so, their remaining admission related activities could not be processed further. Please note that the size of the combined scanned documents must not exceed 24 MB.

Application for hostel accommodation will be invited at the time of re-opening of the Institute for students.
